# What personal data do we collect?

In addition to the information that you yourself provide to us (through what you tell us and what you do with us<sup>2</sup>), we may also obtain information about you from third party sources, namely:

Information about you from a customer or your employer with whom we deal (e.g. your contact details)

### Credit reports, references

□ ✓ Orders relating to you that we receive from third parties (e.g. if we should deliver something to you or do something for you)

**DComments** that concern you, powers of attorney

Excerpts from state registers (e.g. HR)

□ Information from **legal proceedings** in which you are involved; testimonies

Your social media/online activities

Publications in which you appear

# Does personal data go abroad?

## No, that's not planned.

Yes, that is possible in the EEA, but exceptionally in every country in the world (conceivable, especially for online services that we use). If this is a country without sufficient data protection, we conclude the EU standard contractual clauses in particular, but we can also rely on consent or give data abroad in some cases because it is necessary for the execution of a contract where data published by you is concerned or it is necessary for legal proceedings abroad.

# Why do we collect personal data?

We do this for the following purposes (besides those we communicate to you separately):

#### Communication with you

Contract conclusion/processing with you (possibly including for the purpose of employment), your employer and customers

□ ✓ Operation of the **infrastructure**, website, app

■ Marketing (e.g. mailings, with unsubscribe Link/option, occasions), maintaining relationships

□ Market analysis, planning, development of products & services, R&D

**Compliance** (compliance with laws, industry standards, directives, etc.)

- Legal Procedures, Investigations
- □ Safeguard **security**, access control

Management, risk management

- □ Corporate transactions (e.g. **M&A**)
- □ **PR**, shareholder services/IR, publications
- Training, instruction, further education

#### Who do we disclose personal data to?

#### Group companies (see website)

Service providers (who process your data partly on our behalf, e.g. IT providers, partly on their own responsibility, e.g. insurance companies)

- □ **Authorities** domestically and possibly abroad
- **Business partners** such as suppliers, customers, marketing and project partners
- Credit reporting agencies that store this data for credit checks
- ➡ Third parties who collect data about you via the website/app (see list on the website)<sup>3</sup>

#### Your rights?
